The role of the Seniors Navigators is to enhance access to information, and the navigational experiences of near seniors, seniors, their family members, and their caregivers.

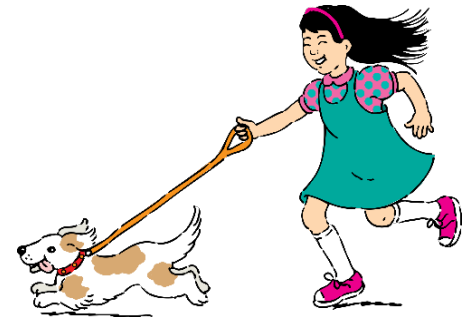
The work of the Seniors Navigators will allow seniors to access programs and services from community organizations, municipal, provincial, and federal governments in a timelier manner.
