Tender to commence **November 15th** – any snow clearing required before this date is billable separately to the Town of North Rustico and must be pre-approved.

Specifications Snow Clearing, Salting/Sanding & Removal Eliyahu Wellness Centre (EWC)

1. Snow clearing/blowing of the EWC's parking lot and fire/emergency access gravel road behind facility of 20 Recreation Drive – See map **RED** highlighted areas requiring clearing. Snow clearing the front entrance, Zamboni room external door and garbage containers at the back side of the car park must be observed as areas included in the red area.
2. Snow banked/piled to the to the back gravel portion of the carpark– See map **GREEN** highlighted areas
3. Snow removed when required so as not to encroach on neighboring properties or asphalted car park area – this must be approved by the EWC prior to the removal event.
4. Salting/Sanding as required (if snow fall is minimal) via pre-approved contractor discretion(s) – See map **BLUE** highlighted areas.
5. Clearing/Blowing Service must be commenced to the **RED** area 5:45am Monday to Saturday and 7am Sunday.
6. At Completion of the Tender (Mar 15th) the **GREEN** area must be moderately flattened/levelled but does not require landscaping or re-seeding of grass.
